- EHL Campus (Singapore) Pte Ltd will deliver the Course as set out in Schedule A to the 1.1 Student, towards conferment of the stated qualification upon successful Course completion.
- **1.2** EHL Campus (Singapore) Pte Ltd confirms that the Course has been permitted by the Committee for Private Education (CPE) and no amendments have been made to the Course as set out in Schedule A, unless otherwise permitted by CPE.
- The Course Fees payable are set out in Schedule B and the optional Miscellaneous Fees 1.3 in Schedule C.
- 1.4 EHL Campus (Singapore) Pte Ltd considers payment made 1 day after the scheduled due date(s) in Schedule B as late. EHL Campus (Singapore) Pte Ltd will explain to the Student its policy for late payment of Course Fees, including any late payment fee charged in Schedule C (if applicable) and any impact on Course/module completion.



2. REFUND POLICY

2.1 <u>Refund for Withdrawal Due to Non-Delivery of Course:</u>

EHL Campus (Singapore) Pte Ltd will notify the Student within three (3) working days upon knowledge of any of the following:

- (i) It does not commence the Course on the Course Commencement Date;
- (ii) It terminates the Course before the Course Commencement Date;
- (iii) It does not complete the Course by the Course Completion Date;
- (iv) It terminates the Course before the Course Completion Date;
- (v) It has not ensured that the Student meets the course entry or matriculation requirement as set by the organisation stated in <u>Schedule A</u> within any stipulated timeline set by CPE; or
- (vi) The Student's Pass application is rejected by Immigration and Checkpoints Authority (ICA).

The Student should be informed in writing of alternative study arrangements (if any), and also be entitled to a refund of the entire Course Fees and Miscellaneous Fees already paid should the Student decide to withdraw, within seven (7) working days of the above notice.

2.2 <u>Refund for Withdrawal Due to Other Reasons:</u>

If the Student withdraws from the Course for any reason other than those stated in Clause 2.1, EHL Campus (Singapore) Pte Ltd will, within seven (7) working days of receiving the Student's written notice of withdrawal, refund to the Student an amount based on the table in <u>Schedule D</u>.

2.3 <u>Refund During Cooling-Off Period:</u>

EHL Campus (Singapore) Pte Ltd will provide the Student with <u>a cooling-off period of</u> <u>seven (7) working days</u> after the date that the Contract has been signed by both parties.

The Student will be refunded the highest percentage (stated in <u>Schedule D</u>) of the fees already paid if the Student submits a written notice of withdrawal to EHL Campus (Singapore) Pte Ltd within the cooling-off period, regardless of whether the Student has started the course or not.



3. ADDITIONAL INFORMATION

- **3.1** The laws of Singapore will apply to how this Contract will be read and to the rights the parties have under this Contract.
- **3.2** If any part of this Contract is not valid for any reason under the law of Singapore, this will not affect any other part of this Contract.
- **3.3** If the Student and EHL Campus (Singapore) Pte Ltd cannot settle a dispute using the way arranged by EHL Campus (Singapore) Pte Ltd, the Student and EHL Campus (Singapore) Pte Ltd may refer the dispute to the CPE Mediation-Arbitration Scheme (www.cpe.gov.sg).
- **3.4** All information given by the Student to EHL Campus (Singapore) Pte Ltd will not be given by EHL Campus (Singapore) Pte Ltd to anyone else, unless the Student signs in writing that he agrees or unless EHL Campus (Singapore) Pte Ltd is allowed to give the information by law.
- **3.5** If there is any other agreement between EHL Campus (Singapore) Pte Ltd and the Student that is different from the terms in this Contract, then the terms in this Contract will apply.
- **3.6** If the Student or EHL Campus (Singapore) Pte Ltd does not exercise or delay exercising any right granted by this Contract, the Student and EHL Campus (Singapore) Pte Ltd will still be able to exercise the same type of right under this Contract during the rest of the time the Contract continues.
- **3.7** If this Contract is also signed or translated in any language other than English and there is a difference from the English language copy of this Contract, the English language copy will apply.
